NOTICE OF PUBLIC MEETING

Farm-to-Market (FM) 1830

**Proposed Improvements to FM 1830 from FM 407 to United States Highway (US) 377
CSJ: 1785-01-038**

The Texas Department of Transportation (TxDOT) will conduct a public meeting for proposed improvements to FM 1830 from FM 407 to US 377 in Denton County, Texas, a distance of approximately 5.4 miles. **The meeting will be held on Tuesday, September 26, 2017 from 6:00 pm to 8:00 pm at Harpool Middle School, located at 9601 Stacey Lane, Lantana, Texas 76226.** Representatives from TxDOT and project consultants will be available to answer questions about the proposed project. It will be conducted in an informal open house format with no formal presentation.

The proposed project would widen FM 1830 from a two-lane roadway to a four-lane roadway. Proposed improvements would include constructing inside 12-foot wide travel lanes (one in each direction) and outside 14-foot wide travel lanes (one in each direction) for shared use by bicycles and vehicles. Sidewalks would also be constructed along on each side of FM 1830 throughout the proposed project limits. Additional right-of-way would be required along existing FM 1830.

Maps showing the project location and preliminary design will be available for viewing at the public meeting. This information is also on file and available for public inspection at the TxDOT Dallas District Office, 4777 E. U.S. Highway 80 Mesquite, TX 75150-6643. Project information will also be available online at www.keepitmovingdallas.com under Upcoming Public Hearing/Meeting.

All interested citizens are invited to attend the public meeting. Written comments from the public regarding this project are requested and will be accepted for a period of 15 calendar days following the public meeting. Written comments may be submitted either in person at the public meeting or by mail to the TxDOT Dallas District Office, Attention Mr. Charles Tapp, P.E., 4777 E. U.S. Highway 80 Mesquite, TX 75150-6643. Written comments must be postmarked on or before Wednesday, October 11, 2017 to be included in the Public Meeting Summary.

The public meeting will be conducted in English. Persons interested in attending the meeting who have special communication or accommodation needs, or need an interpreter, are encouraged to contact the TxDOT Dallas District Public Information Office at (214) 320-4480 at least two working days prior to the public meeting.
