



## NOTICE OF PUBLIC MEETING

Proposed Improvements to I-20 from Duncanville Rd. to Hampton Rd.  
CSJs: 2374-04-081, 2374-04-981

The Texas Department of Transportation (TxDOT) is proposing improvements to I-20 from Duncanville Rd. to Hampton Rd. in Dallas County, Texas, a distance of 3.3 miles. The proposed improvements would add frontage road segments along the interstate where none currently exist to provide continuous one-way frontage roads (two lanes in each direction). Intersection, ramp and main lane improvements would also be considered to accommodate the addition of frontage roads.

**TxDOT is considering significant changes to ramping and access in the vicinity of Redbird Mall/Southwest Center Mall, at the intersection of US 67 and I-20.** TxDOT will conduct a public meeting to discuss changes specific to this area and receive public comments on the proposed improvements. **The public meeting will be held on Tuesday, October 17, 2017 from 6:00 p.m. to 8:00 p.m in an open house format with no formal presentation. The meeting will be held at the Redbird Mall/Southwest Center Mall Atrium, located at 3662 W. Camp Wisdom Road, Dallas, Texas 75237.** Representatives from TxDOT and project consultants will be available to answer questions about the proposed project improvements.

Maps depicting the proposed project's location and information specific to the preliminary geometric design in this area will be available for viewing at the public meeting. General information about the proposed improvements will also be available for public inspection Monday through Friday between the hours of 8:00 a.m. and 5:00 p.m. at the TxDOT Dallas District Office located at 4777 East Highway 80, Mesquite, Texas 75150. All interested persons are invited to attend the public meeting. Written comments from the public are requested and will be accepted for a period of 15 calendar days following the public meeting.
