

## NOTICE OF PUBLIC MEETING

Proposed Improvements to Farm-to-Market Road 2449  
From West of Farm-to-Market Road 156 to Future State Loop 288  
Denton County, Texas  
CSJ: 2352-02-024

The Texas Department of Transportation (TxDOT) is conducting a Feasibility Study for improvements to Farm-to-Market (FM) 2449 from West of FM 156 to Future State Loop (SL) 288 in Denton County, Texas. TxDOT will conduct a public meeting to discuss and receive public comments on the proposed study. **The public meeting will be held on Thursday, January 9, 2020 at Ponder High School (cafeteria), located at 300 West Bailey Street, Ponder, TX 76259.** This meeting will be held in an open house format from 6:00 p.m. to 8:00 p.m. Representatives from TxDOT and project consultants will be available to answer questions about the proposed project improvements.

The purpose of the study is to analyze potential roadway options to improve FM 2449, including improving the existing alignment or utilizing new alignments. Alignment options could require additional right-of-way to accommodate the project.

Maps showing FM 2449 roadway alignment concepts will be available for viewing at the public meeting. This information will also be on file and available for inspection Monday through Friday between the hours of 8:00 a.m. and 5:00 p.m. at the TxDOT Dallas District Office, 4777 E. Highway 80, Mesquite, TX 75150 and the TxDOT Denton County Area Office located at 2624 W. Prairie, Denton, TX 76201. Project information will also be available online at [www.keepitmovingdallas.com](http://www.keepitmovingdallas.com) under Public Hearing/Meetings or [www.txdot.gov](http://www.txdot.gov) under Hearings, Meetings and Notices Schedule.

All interested persons are invited to attend the public meeting. Written comments from the public are requested and will be accepted for a period of 15 calendar days following the meeting.
