### Virtual Public Meeting with In-Person Option

The Texas Department of Transportation (“TxDOT”) is conducting a feasibility study for improvements to I-345 from I-30 to Woodall Rodgers Freeway (Spur 366) in Dallas County, a distance of 1.4 miles. This notice advises the public that TxDOT will be conducting an online, virtual public meeting on the proposed study with an in-person option. **The virtual meeting will be held on Tuesday, June 22, 2021 at 3 PM and remain online through Thursday, July 22, 2021 at 11:59 PM. Please note, this is not a live event. The materials can be viewed at your convenience.** To log onto the virtual public meeting, go to the project website listed above any time during the dates and times indicated above. The meeting will consist of a virtual room and a presentation which will be a pre-recorded video with both audio and visual components. **The virtual room and presentation will not be available on the website until the time and date listed above.** The virtual room and presentation will remain available for viewing at the web address indicated above until Thursday, July 22, 2021 at 11:59 PM. If you do not have internet access and are unable to attend the in-person option, you may call (214) 320-6100 between the hours of 8 AM and 5 PM. Central Time, Monday through Friday, to ask questions, and arrange an appointment to view public meeting materials.

Additionally, TxDOT is providing two in-person meeting options for individuals who would like to participate in person instead of online. In-person attendees will be able to review the same materials via the virtual room and presentation as the online public meeting. The pre-recorded presentation will be playing on a screen, and attendees can ask questions of TxDOT staff and/or consultants, as well as leave written comments. **The in-person meeting dates, times, and locations are listed below:**

A team member will then contact you to schedule an appointment. In recognition of COVID-19, enhanced safety measures will be applied at the in-person option, including a requirement to wear a face mask, temperature check, having a pre-scheduled appointment, and follow social distancing practices. If anyone arrives without an appointment, they may be asked to wait outside to ensure we maintain appropriate occupancy within the meeting space as people with scheduled appointments will receive priority.

Both virtual and in-person attendees will be able to learn about the study process and provide input on the conceptual alternatives for the future of I-345.

Highway 80, Mesquite, Texas 75150. These materials will also be available for review electronically at the in-person meetings.

The virtual public meeting and in-person option will be conducted in English. If you need an interpreter or document translator because English is not your primary language or you have difficulty communicating effectively in English, one will be provided to you. If you have a disability and need assistance, special arrangements can be made to accommodate most needs. Please be aware that advance notice is required as some services and accommodations may require time for TxDOT to arrange.
