**NOTICE OF PUBLIC HEARING
US 377**

The Texas Department of Transportation (TxDOT), in conjunction with the City of Roanoke and Denton County, will hold a public hearing regarding the proposed widening of US 377 from south of Henrietta Creek Road to SH 114 in Roanoke, Texas. The hearing will be held on Tuesday, March 17, 2015 at Roanoke Community Center, 312 S Walnut Street, Roanoke, TX 76262. Displays will be available for viewing at 6 P.M. with the formal hearing commencing at 7 P.M.

The proposed project would widen US 377 from a two-lane rural roadway to a four-lane urban curb and gutter section with an adjacent sidewalk and raised median. Dedicated left-turn lanes would be provided at the signalized intersections of Crockett, Main, and Denton Streets.

The existing US 377 right-of-way width varies from approximately 98 feet to 240 feet. The proposed right-of-way width varies from 99 feet to 240 feet. The estimated additional right-of-way needed for the proposed project is approximately 1.1 acres.

The proposed improvements would result in approximately one displacement. Information concerning relocation services and benefits available to affected residential and commercial property owners and information about the tentative schedules for right-of-way acquisition and construction will be available at the Public Hearing and can also be obtained from the TxDOT Dallas District office.

Maps and other drawings showing the project's proposed location and design will be displayed at the hearing. Environmental documentation for the project will be available for inspection at the hearing. Preliminary plans for the proposed improvements are available for review between the hours of 8 AM and 5 PM at the Denton County Area Office (2624 W Prairie, Denton TX 76201) and the Dallas District Area Office (4777 East Highway 80, Mesquite, TX 75150). All interested citizens are invited to attend this public hearing. Written comments from the public regarding this project are requested and will be accepted for a period of 10 calendar days following the hearing. Written comments may be submitted either in person or by mail to the TxDOT Dallas District, Jim Dobbins, 4777 East Highway 80, Mesquite, Texas 75150. Written comments must be received on or before March 27, 2015 in order to become part of the official hearing record.

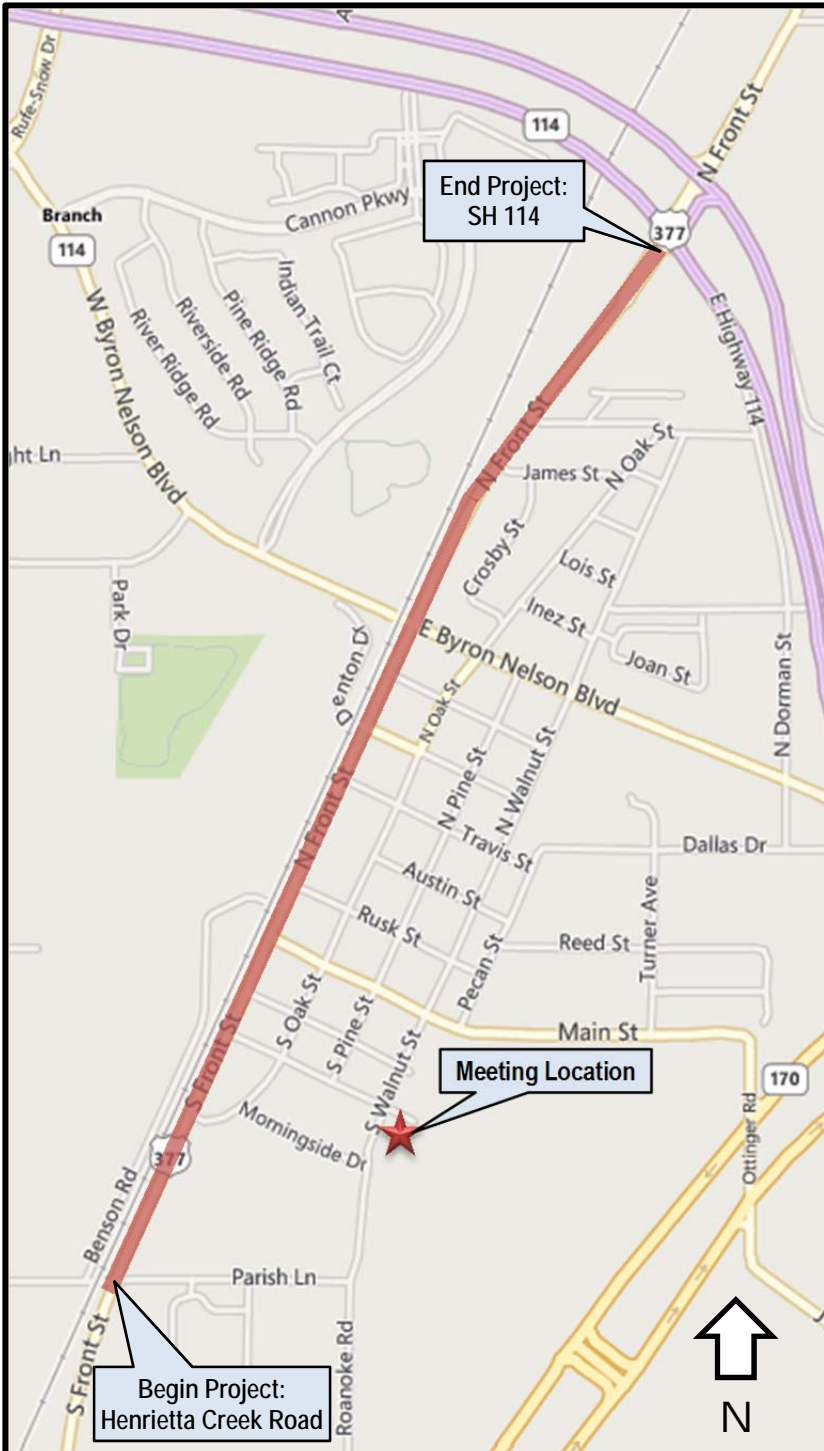
