This notice advises the public that the Texas Department of Transportation (TxDOT) has issued a finding of no significant impact (FONSI) for the proposed I-30 widening freeway project, and that the FONSI is available for public review. The proposed project would reconstruct and widen from eight mainlanes to ten mainlanes and add two reversible managed lanes in the center median, along I-30 from I-45 to Ferguson Road in Dallas County, Texas.

The FONSI and approved final environmental assessment (EA) are on file and available for inspection Monday through Friday between the hours of 8 a.m. and 5 p.m. at TxDOT Dallas District Office at 4777 East US Highway 80, Mesquite, TX 75150-6643; (214) 320-6200.
