**Finding of No Significant Impact

This notice advises the public that the Texas Department of Transportation (TxDOT) has issued a finding of no significant impact (FONSI) for the proposed reconstruction of I-345 and that the FONSI is available for public review. The proposed project would reconstruct existing roadway and interchanges of I-345, from I-30 to SS 366 in Dallas County, Texas.

The FONSI and approved final environmental assessment (EA) are on file and available for inspection Monday through Friday between the hours of 8 a.m. and 5 p.m. at TxDOT Dallas District Office at 4777 East US Highway 80, Mesquite, TX 75150-6643; (214) 320-6675.
