

NOTICE OF PUBLIC MEETING

United States Highway (US) 175
From Farm-to-Market Road (FM) 148
To County Road (CR) 4104
Kaufman County, Texas

The Texas Department of Transportation (TxDOT) will conduct a Public Meeting for the purpose of soliciting public comments on the proposed roadway improvements to US 175, from FM 148 to CR 4104 in the City of Crandall, Kaufman County, Texas. The meeting will be held on Thursday, June 29, 2017 from 6:00 p.m. to 8:00 p.m. at the Crandall High School Cafeteria, 13385 FM 3039 Crandall, TX 75114. Maps and displays will be available for viewing during the meeting and representatives from TxDOT, Kaufman County, and project staff will be available to answer questions about the proposed project. The meeting will be conducted in an open house format with no formal presentation.

The proposed project would extend from FM 148 in eastern Crandall to CR 4104 - a total length of approximately 2.7 miles. The proposed project would entail the construction of a new frontage road between FM 148 and CR 4104 on the south side of US 175. The proposed project would require approximately 41 acres of proposed right-of-way (ROW) and an estimate of 0.42 acres of proposed permanent easements.

Maps showing the project location and draft schematic design will be available for viewing at the public meeting. The schematic is also available for public inspection at the City of Crandall City Hall, 110 S. Main Street, Crandall, Texas 75114; TxDOT Dallas District Office, 4777 East Highway 80, Mesquite, Texas 75150; and the TxDOT Rockwall/Kaufman County Area Office, 2750 S. Washington, Kaufman, Texas 75142. This notice and a map with directions to the meeting will be available online at www.keepitmovingdallas.com under Upcoming Public Hearing/Meeting.

All interested persons are invited to attend this public meeting and express their views on the proposed project. Written comments from the public are requested and may be submitted at the meeting and by mail for a period of 15 calendar days following the meeting to the following address: Texas Department of Transportation, Attention: Ms. Nancy Peron, P.E., 4777 East Highway 80, Mesquite, Texas 75150. Comments may also be emailed to nancy.peron@txdot.gov. Comments submitted after the meeting must be received or postmarked by **Friday July 14, 2017** to be part of the public meeting record.

The meeting will be conducted in English.
