



NOTICE OF PUBLIC HEARING

**Proposed Improvements to United States Highway (US) 175
From Farm-to-Market Road (FM) 148
To County Road (CR) 4106 in Crandall
Kaufman County, Texas**

The Texas Department of Transportation (TxDOT) will conduct a Public Hearing regarding the proposed roadway improvements to US 175, from FM 148 to CR 4104 in the City of Crandall, Kaufman County, Texas. **The meeting will be held on Thursday, January 10, 2019 from 6:00 p.m. to 8:00 p.m. at the in the L.F. Raynes Board Room, Crandall Independent School District, 400 West Lewis Street, Crandall, TX 75114.** Displays will be available for viewing at 6:00 p.m. with the formal hearing starting at 7:00 p.m. The purpose of the public hearing is to present the proposed project to the public and receive comments.

The proposed project is located along US 175 from FM 148 to CR 4106 in eastern Crandall, Kaufman County, Texas, a total length of approximately 2.8 miles. This proposed project would consist of the construction of a new frontage road on the south side of US 175 between FM 148 and CR 4106, and the conversion of the existing two-way frontage road on the north side of US 175 to one-way operation. The proposed project would require approximately 32 acres of proposed right-of-way and 0.72 acre of permanent easements.

Environmental documentation, maps showing the project location, and other information regarding the project are on file and available for public inspection at the TxDOT Dallas District Office, 4777 East Highway 80, Mesquite, Texas 75150. This information will also be available for inspection at the public hearing. A copy of the approved schematic and of this hearing notice is available online at www.keepitmovingdallas.com under Upcoming Public Hearing/Meeting.

All interested persons are invited to attend this public hearing and express their views on the proposed project. Written and verbal comments from the public regarding this project are requested and may be presented at the public hearing, or submitted by mail to the TxDOT Dallas District Office, Attention: Ms. Rakhshanda Mahar, P.E., 4777 East Highway 80, Mesquite, Texas 75150.
