

## NOTICE OF PUBLIC MEETING

## PROPOSED WIDENING OF FARM-TO-MARKET (FM) 2514 (PARKER ROAD) FROM EAST OF LAVON PARKWAY TO BROWN STREET IN COLLIN COUNTY, TX

The Texas Department of Transportation (TxDOT) will hold a public meeting regarding the proposed widening of Farm-To-Market (FM) 2514 (Parker Road) from east of Lavon Parkway to Brown Street in the City of Wylie and the Town of St. Paul, and unincorporated areas in Collin County, Texas. The project length is approximately 3.4 miles. The meeting will be held on Tuesday, May 19, 2015, at the Davis Intermediate School Cafeteria, 950 Park Boulevard, Wylie, Texas 75098. The meeting will be held in an open house format from 5:30 p.m. to 7:30 p.m.

The purpose of the Public Meeting is to present the proposed project to the public and receive comments. The proposed project would reconstruct and widen this section of FM 2514 from a 2-lane undivided roadway to a 4-lane (ultimate 6-lane) urban divided roadway. The purpose of the project is to reduce congestion, enhance safety by accommodating traffic volumes which are expected to double on this section of FM 2514 in the next 20 years. The proposed improvements may potentially require additional right-of-way (ROW); however, displacements (commercial or residential) are not anticipated as a result of the proposed project.

Maps showing the proposed project's location and geometric design will be available for viewing at the public meeting. This and other public information will also be on file and available for public inspection at the TxDOT Dallas District Office located at 4777 East Highway 80, Mesquite, TX 75150 and the TxDOT Collin County Area Office located at 2205 South SH 5, McKinney, Texas, 75069. This information will also be available online at www.keepitmovingdallas.com under Upcoming Public Hearing/Meeting.

All interested citizens are invited to attend this Public Meeting. Written comments from the public regarding this project are requested and may be presented for a period of 10 calendar days following the meeting. Written comments may be submitted either in person or by mail to Mr. Bruce Nolley, P.E. at the TxDOT Dallas District Office located at 4777 East Highway 80, Mesquite, Texas 75150. Written comments must be postmarked by Friday, May 29, 2015 to be included in the Public Meeting Summary.

The Public Meeting will be conducted in English. Persons interested in attending the meeting who have special communication or accommodation needs, or need an interpreter, are encouraged to contact the TxDOT Dallas District Public Information Office at (214) 320-4480.
