Per the new 401 Certification Rule, an applicant seeking an individual 404 permit for which a 401 water quality certification is required, will need to request a "Pre-filing Meeting" with TCEQ at least 30 days prior to requesting a 401 water quality certification. It looks like this project may be permitted using a Nationwide permit, in which case a separate TCEQ 401 water quality certification would not be needed, since the 401 certification is essentially built into the Nationwide permit since we certified those back in 2017. That being the case, a Pre-filing meeting request is not needed. However, if it's possible that things may change and a 404 individual permit is required, a Pre-filing meeting request will have to be submitted at least 30 days prior to requesting a 401 water quality certification in order to satisfy the requirement of the 401 Certification Rule.

The purple route would have the least impact to floodplains, wetlands, streams, and habitat for wildlife and aquatic species. ▪ TPWD specifically advises against and strongly discourages the selection of alignments that propose a new crossing over the East Fork Trinity River, such as the Orange Route. TPWD has concerns that the Orange Route would result in new disturbances to the Trinity River and fragment riparian areas and negatively affect water quality. ▪ TPWD recommends referring to the Texas Conservation Action Plans (TCAP), TPWD Rare, Threatened, and Endangered Species of Texas

(RTEST) by County application, and the Texas Natural Diversity Database (TXNDD), and Ecological Mapping System of Texas (EMST) for information regarding sensitive resources potentially occurring in the area, priority habitats, and issues affecting sensitive resources within Collin County and avoid adverse impacts to these resources by route selection and or adjustments.

- TPWD recommends TxDOT consider potential impacts to wildlife travel corridors and incorporate wildlife crossings into design strategies to avoid further fragmentation of native habitats and minimize wildlife-vehicle interactions. Further, TPWD encourages TxDOT to consider opportunities within the study area to modify bridges and culverts to further enhance wildlife passage.
- TPWD recommends choosing the alignment with the least impact on wetlands and streams. Impacts at stream crossings should be minimized during the design phase by spanning stream channels and other water features when feasible, reducing culvert lengths, and utilizing metal-beam guard fence to increase slope angles and reduce embankment. The central low-flow culvert(s) should be large enough to handle the 1.5-year flow, culvert bottoms should be set at least a foot below grade and installed in the thalweg and be aligned with the low-flow channel.
- State-listed mussels have the potential to occur within perennial streams or intermittent streams with perennial pools in Collin County. TPWD recommends further evaluating species where suitable habitat may be present and relocating potentially impacted native aquatic resources in conjunction with a Permit to Introduce Fish, Shellfish or Aquatic Plants into Public Waters and an Aquatic Resource Relocation Plan (ARRP) if dewatering activities are required.
- TPWD recommends TxDOT consider wildlife impacts from light pollution and incorporating dark-sky lighting practices into design strategies.
- The Land and Water Resource Conservation and Recreation Plan (LWRCRP) inventory indicated parks located within the project area. The TPWD Recreation Grants Program should be contacted to determine whether TxDOT's proposed Spur 399 Extension project may impact Land and Water Conservation Fund (LWCF) projects.

The reason for my opposition of the orange alternative in the Spur 399 extension is the history of the land you would be destroying. The land County Road 722 runs through has been in my husband's family for over 160 years. We believe it was originally named Enloe Road after my husband's great-great-great-grandfather Abraham Enloe (b.1802) or his son and noted pioneer settler of Collin County, Reverend Abe Enloe (b.1845). The Enloe family moved here to Collin County from Missouri when Rev. Abe was just five years old in December of 1850 on an ox-driven wagon. His father, Abraham Enloe built his family farm of approximately 75 acres on this land he purchased in 1857. It is noted in Collin County History from early 1938 that this area southeast of McKinney on the west bank of the East Fork of the Trinity River was known as the Enloe Community. Records say Abe Enloe gave a portion of that land for a schoolhouse to be built so the children could attend school in 1858. It was known as the Enloe Schoolhouse. The younger Reverend Abe Enloe found his way back to the Enloe community after fighting in the Civil War to farm and raise his family. Records say he freighted cotton and brought back lumber from which the early homes in Collin County were built. He lived and built the home that still stands today at 2142 CR 722. Since then, five generations have lived and raised families in that home. My husband's parents lovingly raised their five children and still live in that home. Since we began a family of our own, my husband and I have dreamt that our infant daughter will be able to explore this historic land like the six generations before her. In 1984, the Texas Department of Agriculture presented my husband's grandparents the Texas Family Land Heritage Certificate for the Enloe farm. This certificate honors families who have continuously operated Texas farms and ranches for at least 100 years. At the time, the farm had already been in operation for 127 years. My husband's sweet 100-year-old grandmother, Minnie Fae (granddaughter of Reverend Abe Enloe), still proudly displays that plaque in her home off CR722 (on the land of the proposed orange alternative) that she is still living in today. Some 162 years later and after years of back breaking work, the family trust has since grown to approximately 200 acres and has seen seven generations thus far. There are currently four homes with four loving families sitting on the family trust with family members in age ranging from three years old to 100 years old. Our youngest generation of Enloe descendants is currently raising chickens on this farmland while his grandparents continue to farm the family land growing wheat and tending to livestock today. I grew up in McKinney, Texas. I've watched the growth our small town undergoes year after year, and I understand the need for traffic congestion relief. We currently have approximately 5,800 LF of frontage on both sides of the existing Airport Road. We are and have been in the process of expanding our facilities and are concerned about right of way impacts and access impacts. We currently have four access points from our east plant facility and have plans for an at-grade rail crossing. We have recent began expanding our facilities north of our current facility (north of old Elm Street) and are looking to build soon on the east side of Airport Road.</p> <p>We are greatly concerned with the two options presented for west of the airport. Both west options 1 & 2 require extreme amounts of additional right of way. It is estimated that 35 to 40 acres of additional right of way should be taken in the proposed Options 1 & 2, from Encore Wire. The current ROW width for Airport Road is 130 feet. Proposed ROW for the SP 399 freeway section is 320 feet to 400 feet. This would result in the taking up to an additional 420 feet for a total width of 560 feet as shown in option 2. Access due to either west option severely restricts the access to both existing Encore Wire facilities and planned future expansion. These comments and concerns are in reference to my review of the slides from the recent Virtual Public Scoping Meeting. The original plan shows the proposed construction (Purple Alternative Slide #27) starting close to the intersection of TX Hwy 75 and the end of the Hwy 121 Toll Road turning to the East onto the current Harry McKillop Blvd and the turning to North following the general alignment of Airport road before connecting to the Hwy 380. My areas of concern and comments follow:</p> <p>1.Current access to the entrance of McKinney National Airport from the North and South occur from Airport Road from either direction turning onto Industrial Blvd while from the West is directly into the airport property on Industrial Blvd. One would have to assume that some type of crossing either overpass or underpass of Industrial Blvd or the new alignment of Spur 399 would be required for traffic arriving from any direction accessing the Industrial Blvd entrance. Considering the amount of vehicle traffic going to/from the airport and the fact that McKinney Fire Station #4 is immediately on the West side of the airport which not only services the airport but most of East McKinney one would believe this unrestricted access would need to be a priority for everyone's safety and expediency for the Fire Department.</p> <p>2.Given the lateral distances between the South East Corner of the existing Encore Wire Building on the same corner of Industrial Blvd and Airport Road it would seem there is probably not enough room for an elevated Industrial Blvd that would also include North/South access to a new Spur 399 to be possible. This situation has been further complicated by the recently constructed Amazon Delivery Center with the North West corner of that facility being located close the South East Corner of Industrial Blvd and Airport Road.</p> <p>3. Another issue with this alignment has to do with drainage of the water coming from this intersection and from the area to the South West of the Industrial Blvd. and West of Airport Road. Adding all the paving lanes to this area would increase the amount of fast flow water coming off the paved area that would flow to a small creek that crosses Airport Road just to the East of the aforementioned Encore Wire Building on the West side of Airport Blvd. This small creek then proceeds to the East through a security swing gate and crosses the West end extension of Taxiway B2 at McKinney National Airport and then proceeds to the East into a larger drainage ditch. On the City of McKinney property where the (MHOA) McKinney Hanger Owners Association leased property is located there is an inlet which is designed to drain excess water from this creek through a concrete tube that is under the MHOA ramp and continues to the East and discharges into a North South drainage ditch which then exits underground through a flume under the North Ramp at the Airport. The problem is during heavy rainfalls this small ditch has filled to the point of flooding many of the MHOA hangers. There have been several changes to correct some issues with the concrete tube under the MHOA hangers and with the security gate prior to the flume that carries the water from the small ditch under the Taxiway B2 extension but with the excess fast runoff from the paving there must be concern that the flooding will return.</p>

A freeway through our property would displace 13 horses that need a home. • Route option “C” would impact more habitable structures and businesses than option “D”. • Route option “C” would impact more trees and more forested areas than option “D”. • It is unjust to put the burden of population growth and mobility needs on us and our neighbors. We moved to our current location with the intent of getting away from highways and busy thoroughfares - we would never have dreamed of building a home on, let alone near a state highway. Those businesses or residents that built or purchased on State Highway 380 did so with full knowledge of risk of future expansion, improvements, and other changes – yet we are being asked to bear the burden. • A bypass is in direct conflict with McKinney’s 2040 plan passed in October 2018 which mentions “viable multi-modal options.” An eight-lane freeway does not provide “multi-modal” options. • Spring and fall 2018 TxDOT survey results show an overwhelming majority of those surveyed prefer to keep 380 on 380. • If a bypass route is selected, US HWY 380 will still require significant investment due to the growing retail sprouting up along it, bringing increased traffic. <p>As a reminder, our properties are in the McKinney ETJ at 2280 CR 338 (5.98 acres occupied by primary residence, six stall barn and equine arena; property ID: 2768330); 2172 CR 338 (5.52 acres occupied by guest house, equine training pen and five stall barn; property ID: 2768334); and 2150 CR 338 (12.0 acres occupied by four stall barn). 2280 CR 338 has dual usage – our primary residence as well as part of the Swim’s My Lil Serenity Equine rescue. 2172 CR 338 has dual usage as well, acting as guest house for our daughter Jennifer and is also part of the Equine rescue. 2150 CR 338 primary use is the equine rescue. All three properties are used not only for hay harvesting but also act as the primary source of forage for the horses.
