



NOTICE OF PUBLIC MEETING
STATE HIGHWAY (SH) 114 IMPROVEMENTS
From Interstate Highway (IH) 35 West to United States Highway (US) 377
Denton County, Texas
CSJ No. 0353-02-037, 0353-09-003

The Texas Department of Transportation (TxDOT) will conduct a Public Meeting for the purpose of soliciting public comments on proposed SH 114 improvement project from IH 35 West to US 377, a distance of approximately 2.6 miles near Roanoke, Texas. The meeting will be held on **Tuesday, December 17, 2019 from 6:00 p.m. to 8:00 p.m. at the Gene Pike Middle School Cafeteria, located at 2200 Texan Dr, Justin, TX 76247.** Representatives from TxDOT and project consultants will be available to answer questions about the proposed project. The meeting will be an open house format with no formal presentation.

The proposed improvements include constructing a new 6-lane rural freeway with 2 to 3-lane frontage roads in each direction and ramps. There are two cross streets within the project limits. At Cleveland Gibbs Road/Dale Earnhardt Way, the mainlanes will cross with an overpass and the Litsey Road/Briarwick Parkway interchange will be an underpass. The proposed project includes constructing six 12-foot wide mainlanes and reconstructing four to six 12-foot wide frontage road lanes with 4-foot inside and 10-foot outside shoulder. The mainlanes will be divided with a concrete barrier along the centerline. The existing right-of-way width along SH 114 varies from 420 to 500-feet in width and along Dale Earnhardt Way the width is 80-feet. Approximately 0.13 acres of right-of-way would be required to widen Dale Earnhardt Way. The project as proposed would not result in any displacement.

Maps showing the proposed project's location and geometric design will be available for viewing at the public meeting. This information will also be on file and available for inspection Monday through Friday between the hours of 8:00 a.m. and 5:00 p.m. at the TxDOT Dallas District Office, 4777 E. Highway 80, Mesquite, TX 75150 and the TxDOT Denton County Area Office, 2624 W. Prairie Street, Denton, TX 76201. Project information will also be available online at www.KeepItMovingDallas.com under Upcoming Public Hearings/Meetings.

Written comments from the public are requested and will be accepted for a period of 15 calendar days following the meeting. Written comments may be submitted either in person at the public meeting, by mail to the TxDOT Dallas District Office, Attention: Mr. Nelson Underwood, P.E., 4777 E. Highway 80, Mesquite, TX 75150-6643, or by email addressed to Nelson.Underwood@txdot.gov. **Written comments must be postmarked by Friday, January 3, 2020, to be included in the Public Meeting documentation.**
