

#### **Existing Roadway**



#### Existing FM 664:

- Mainly consists of two undivided 11-foot wide rural lanes with 3-foot wide shoulders.
- Existing right-of-way (ROW) varies from 80 feet to 100 feet wide.
- Four major roads intersect FM 664 including:
  - Marshall Road


• FM 1387

Shiloh Road




#### Proposed Roadway



#### Project improvements would include:

- Expansion of the current 2-lane rural roadway to a 4-lane urban roadway (ultimate 6-lanes).
- Proposed ROW varies from 137 feet to 225 feet wide.
- Raised median.
- 12-foot wide travel lanes, 14-foot wide outside shared-use lanes, and 6-foot sidewalks in both directions.
- Eliminating 90-degree turns along FM 664.
