NOTICE OF PUBLIC MEETING
INTERSTATE HIGHWAY (IH) 635 LBJ EAST ULTIMATE PROJECT
From US 75 to IH 30
Cities of Dallas, Garland, and Mesquite, Dallas County, Texas

The Texas Department of Transportation (TxDOT) will hold a Public Meeting regarding the proposed IH 635 LBJ East Ultimate Project from US 75 to IH 30 in the cities of Dallas, Garland, and Mesquite, Dallas County, Texas. The meeting will be held on Tuesday, April 19, 2016, at the Highland Oaks Church of Christ, 10805 Walnut Hill Lane, Dallas, Texas 75238. The meeting will be held in an open house format from 5:00 p.m. to 7:00 p.m.

The purpose of the public meeting is to present the proposed project to the public and receive comments. The project proposes improvements to IH 635 from east of US 75 to south of IH 30 and to IH 30 from west of Gus Thomasson Road to east of North Galloway Avenue. The proposed project would reconstruct IH 635 to provide five general-purpose lanes, two tolled-managed lanes, and two to three frontage road lanes in each direction from US 75 to near Royal Lane/Miller Road. From near Royal Lane/Miller Road to La Prada Drive, the proposed project would reconstruct IH 635 to provide five general-purpose lanes, two non-tolled express lanes, and two to three frontage road lanes in each direction. From La Prada Drive to south of IH 30, the project would reconstruct IH 635 to provide lane balance transitions between the general purpose lanes, proposed express lanes, and IH 30 interchange. Additionally, two to three frontage road lanes would be constructed in each direction from La Prada to Town East Boulevard. Improvements to IH 30 would include reconstructing the main lanes to provide at least three lanes in each direction through the IH 635 interchange with allowances provided for potential future managed/express lanes. Auxiliary lanes would also be constructed for the IH 635 interchange. The IH 30 improvements would include two to three lane frontage roads in each direction. Additionally, the proposed project includes the construction of multiple noise walls located along the project corridor, where reasonable and feasible.

Maps showing the proposed project's location and geometric design will be available for viewing at the public meeting. This information will also be available for public inspection Monday through Friday between the hours of 8:00 a.m. and 5:00 p.m. at the TxDOT Dallas District Office located at 4777 East Highway 80, Mesquite, Texas 75150.

All interested citizens are invited to attend this public meeting. Written comments from the public regarding this project are requested and will be accepted for a period of 10 calendar days following the meeting. Written comments may be submitted either in person or by mail to Mr. Stephen Endres, P.E. at the TxDOT Dallas District Office, 4777 E. Highway 80, Mesquite, Texas 75150-6643. Written comments must be postmarked by Friday, April 29, 2016 to be included in the Public Meeting Summary.

The public meeting will be conducted in English. Persons interested in attending the meeting who have special communication or accommodation needs, or need an interpreter, are encouraged to contact the TxDOT Dallas District Public Information Office at (214) 320-4480. Requests should be made at least two days prior to the public meeting. Every reasonable effort will be made to accommodate these needs.
