

NOTICE OF PUBLIC MEETING

Improvements to SH 352 From North of Kearney Street to US 80 EB Frontage Road Dallas County CSJ: 0430-01-057

The Texas Department of Transportation (TxDOT) will conduct a Public Meeting for the purpose of soliciting public comment on the proposed improvements to State Highway (SH) 352 from North of Kearney Street to US Highway 80 EB Frontage Road in Dallas County, Texas. The meeting will be held at the **Sunnyvale Town Hall, 127 Collins Road, Mesquite, TX 75182 on Tuesday, August 23, 2016**. The Public Meeting will be an Open House format between the hours of 5:00 pm and 7:00 pm with no formal presentation.

The proposed improvements of SH 352 would include construction of a four-lane divided urban roadway with curb and gutter, along with a raised center median. At the southern end of the project, the roadway would transition back into a four-lane urban undivided roadway to match with the existing roadway section further south. The proposed roadway section would consist of one 12-foot wide travel lane and one 14-foot wide outside shared-use lane to facilitate bicycle use in each direction. A one-foot curb offset would be constructed on both the inside and outside lanes. The roadway would be divided by a 17-foot raised median. The typical proposed ROW width is between 118 and 143 feet. Several 11-foot left and/or right turn lanes would be constructed at major intersections and median openings. The existing signalized intersection at Clay Road would include 11-foot dual left turn lanes and a dedicated 11-foot right turn lane on the southbound direction. Five-foot sidewalk with three-foot buffer would be constructed within the ROW on both sides of the roadway beginning from US 80 EB frontage road to just north of Old Barn Lane, followed by a six-foot sidewalk adjacent to curb for the rest of the project limit. The total project length is approximately 1.08 miles.

The proposed project would require approximately 2.7 acres of additional right-of-way and 0.2 acres of drainage easements. No residential or commercial property displacements or relocations would be required.

Maps showing the proposed project's location and geometric design will be available for viewing at the public meeting. This and other public information is also on file and available for public inspection at the TxDOT Dallas District Office located at 4777 East Highway 80, Mesquite, TX 75150. This information will also be available online at www.keepitmovingdallas.com under Upcoming Public Hearing/Meeting.

All interested persons are invited to attend this Public Meeting and express their views on this proposed project. Written comments from the public regarding this project are requested and will be accepted for a period of 10 calendar days following the meeting. Written comments must be postmarked by Friday, September 2, 2016 to be included in the Public Meeting Summary. Persons interested in attending this meeting who have special communication or accommodation needs are encouraged to contact the TxDOT Dallas District Public Information Office at (214) 320-6100 at least two working days prior to the meeting. Because the Public Meeting will be conducted in English, any requests for language interpreters or other special communication needs should also be made at least two (2) days prior to the Public Meeting. Every reasonable effort will be made to accommodate these needs.

The environmental review, consultation, and other actions required by applicable Federal environmental laws for this project are being, or have been, carried-out by TxDOT pursuant to 23 U.S.C. 327 and a Memorandum of Understanding dated December 16, 2014, and executed by FHWA and TxDOT.
