

## Notice Virtual Public Meeting with In-Person Option FARM-TO-MARKET ROAD (FM) 982 PROJECT From United States Highway (US) 380 to FM 546 CSJ: 0387-05-027 Collin County, Texas

TxDOT is proposing to widen Farm-to-Market Road (FM) 982 from United States Highway (US) 380 to FM 546 in Collin County, Texas. This notice advises the public that TxDOT will be conducting an online virtual public meeting on the proposed project with an in-person option. The virtual meeting will consist of a pre-recorded video presentation and will include both audio and visual components. The presentation will be posted online by Tuesday, December 9, 2025, at 5 p.m., and will remain online for at least 15 days. Additionally, TxDOT is providing an in-person option for individuals who would like to participate in person instead of online. The in-person option will be held in open house format. In-person attendees will be able to view the same presentation delivered in the online public meeting which will be playing on a screen, review hard copies of project materials, ask questions of TxDOT staff and/or consultants, and leave written comments. The in-person option will be held on Tuesday, December 9, 2025, from 5 p.m. to 7 p.m. at the Longhorn 2020 Event Center, 3670 FM 982, Princeton, TX 75407.

ask questions and access project materials during the project development process.

The proposed project would widen the FM 982 roadway to a four-lane divided roadway. A 10-foot-wide shared-use path would be constructed on both sides of the roadway. However, between US 380 and CR 400 (Myrick Lane)/FM 452, a six-foot-wide sidewalk would be constructed on the southbound side of the roadway, which would transition to a shared-use path. Proposed drainage would consist of curb and gutter throughout the project limits. The proposed right-of-way (ROW) width varies throughout the project limits but is typically 120 feet.

The proposed project would, subject to final design considerations, require additional right of way and potentially displace one residential structure. Relocation assistance is available for displaced persons and businesses. Information about the TxDOT Relocation Assistance Program and services and benefits for those displaced and other affected property owners, as well as information about the tentative schedule for right-of-way acquisition and construction, can be obtained from the TxDOT district office by calling (214) 320-6675.

The proposed project may involve construction in wetlands and would involve an action in a floodplain.

Any environmental documentation or studies, any maps and drawings showing the project location and design, tentative construction schedules, and other information regarding the proposed project will be on file and available for inspection by appointment Monday through Friday between the hours of 8 a.m. and 5 p.m. starting December 9, 2025, at TxDOT Dallas District Office, 4777 East US Highway 80, Mesquite, TX 75150-6643. Please call (214) 320-6244 to make an appointment. The virtual public meeting and in-person option will be conducted in English.
